

**ANNOUNCEMENT OF THE CENTRAL BANK OF CYPRUS**

**Issue of sets:**  
**- first Cyprus euro coins**  
**- last cent coins of the Cyprus pound**

The Central Bank of Cyprus, in view of the introduction of the euro in Cyprus on 1 January 2008, announces the issue of the following collector items:

- a) A set of the first Cyprus euro coins in BU condition and issue year 2008.
- b) A set of the last Cyprus pound cent coins in uncirculated condition, minted in 2004.

The coins are set in a three - ply brochure placed in a case.

Issue limits and prices per set for sales over the counter at the Central Bank of Cyprus or through other banks in Cyprus are indicated below:

	<u>Issue limit</u>	<u>Price per set</u>	
Set of the first Cyprus euro coins	70.000	£16,39	€28,00
Set of the last Cyprus pound cent coins	8.500	£10,00	€17,09

From the total issue limit of 70.000 sets of the first Cyprus euro coins, 60.000 are allocated for the sales outside Cyprus and 10.000 are reserved for the domestic sales.

The 8.500 sets of the last Cyprus pound cent coins are both for domestic sales and sales abroad. Prices for the dispatch and sale of this set abroad are quoted in euro in the appended price list.

**Sales of the set of the first Cyprus euro coins**

The Mint of Finland (MoF) has been given exclusive right for the sale of the first set of the Cyprus euro coins outside Cyprus. Hence, the MoF will sell this set outside Cyprus through its official distributors. The Central Bank of Cyprus, which has the exclusive right for the domestic sales, will sell the set within Cyprus.



**It should be noted that the euro will not be legal tender in Cyprus before 1 January 2008.**

**Sales of the set of the last Cyprus pound cent coins**



The Central Bank of Cyprus will sell up to 3 sets of the last Cyprus pound cent coins to collectors from 3 December 2007 until 21 December 2007. However, the Bank reserves the right to terminate this period earlier, if available quantities are sold out. In such a case an announcement in the local press and on the Bank's website will be issued.

Applications from overseas collectors for up to 3 sets of the last Cyprus pound cent coins will be satisfied provided they arrive within the aforesaid period and are accompanied by:

- a banker's draft in Euro payable to the order of the Central Bank of Cyprus drawn on a bank located in any country of the EU
- a remittance by SWIFT transfer as per details shown below, for the credit of the Central Bank of Cyprus IBAN code FR 76 30003 06990 0030155 4039 94 (SWIFT Code SOGEFRPP)
